#### **OVAS Property Update**

We last updated you about the status of the property we owned in Orange County in our March/April 2020 The Limpkin Call newsletter (<a href="https://oklawaha-valley-audubon.org/wp-content/uploads/2020/02/2020-Mar-Apr-Limpkin-Call-reduced.pdf">https://oklawaha-valley-audubon.org/wp-content/uploads/2020/02/2020-Mar-Apr-Limpkin-Call-reduced.pdf</a>) and followed up with an explanation to members attending the Annual Meeting on March 1, 2020. Since, the issue was litigated and upon the advice of our attorney, we could not discuss the matter further.

We were fortunate to have Business and Management Insurance that covered the costs to defend OVAS and the individual defendants (Board members). We now are happy to report that the matter has been resolved. The property has been transferred to the Catholic Diocese of Orlando at no cost to OVAS. Upon the transfer, the property is encumbered with a Conservation Easement.

#### **Audubon Climate Watch**

A new community science program explores how North American birds are responding to climate change

According to Audubon's 2019 climate change report, <u>'Survival By Degrees,'</u> up to two-thirds of North American birds are vulnerable to extinction due to climate change. The good news is that there are <u>plenty of opportunities to protect birds</u> from this existential threat, and Audubon members have been leading the way for years.

#### **ECOEXPO 2024 - BIGGER AND BETTER THAN EVER**

Lake County EcoExpo 2024 will happen Saturday March 2 in the Lake Square Mall at 10401 US Hwy 441 in Leesburg. The theme of this year's EcoExpo is "Lake County – Let's Go Green!". OVAS will be a Supporter and exhibitor, as it has been for the two previous EcoExpo's. This year's event will be much bigger than last year, taking advantage of the large and comfortable space available at the Mall. There will be more than 50 exhibits, from conservation organizations and numerous government agencies, and from green businesses, included for the first time this year. Among the first time exhibits is a gallery of twenty environmental maps of Lake County produced by GIS. Climate First Bank is sponsoring a poster contest for high school students, and 50 posters will be on display. Trout Lake Nature Center will have an interactive exhibit. The exhibits will be open from 10:00 a.m. to 4:00 p.m.

More than 20 speakers from government and academia and business will speak on topics including smart growth, sustainability, energy alternatives, climate change, and community resilience. The **keynote speaker** will be Lake County Commissioner Doug Shields. The prizes for the poster contest will also be awarded. The speaker sessions will be from 9:00 a.m. to 5:00 p.m.

This will be an exciting day devoted to conservation and the environment. Come and learn and enjoy it! Bring friends – the EcoExpo is free and is open to all. Don't miss it!

From the Central Florida Regional Conservation Committee meeting January 28, 2024

#### RCC Members and Friends:

The pace of success conserving lands important to wildlife habitat and water resources in Florida increased markedly in 2023. Because of significantly increased conservation land and easement purchase funds provided by the Legislature, the state acquired land and easements preserving some 111,399 acres from January through December, at a total cost of \$305,118,465.

That is over 174 square miles of Florida that will never be developed, where birds and wildlife can thrive, aquifers can be recharged by rainfall, and water stored naturally in wetlands, lakes and streams. **That is an area significantly larger than the City of Orlando!** 

The properties purchased or placed under protective conservation easements include land vital to the Everglades and the Kissimmee River system, including over 10,000 acres in the Fisheating Creek watershed, 17,000 acres in the Devils Garden Swamp in Hendry County, and 8,000 acres in the Everglades Headwaters National Wildlife Refuge; all places needed to assemble the Florida Wildlife Corridor. The places protected span the entire geography of the state, with over 12,000 acres now in state ownership within the Telogia Creek watershed in Liberty County in Florida's panhandle, and important sections of the Rainbow River and the Ocala National Forest in Marion County.

Florida land managers demonstrated good judgment and effective negotiation by bringing this land into protection at remarkably reasonable prices, with the cost per acre averaging \$2,738, which is only a small fraction of the price often paid for land in our rapidly growing state. We are truly excited about the opportunity to participate in the effort to bring about more great land and easement purchases in 2024!

(NOTE – The lands & easements covered in this report are only those purchased through the Florida Forever and Rural programs that were the subject of final decisions by the Governor and Cabinet. There are MORE lands that were acquired under local government environmental land purchase programs and Water Management District land purchase programs that are not reflected in the list above, so the actual total acres protected statewide would be higher if those acres were added to this list.)

#### Balancing Development And Nature Preservation In Lake County, Florida

#### **Watch Video Here**

As some of you know, Lake County would like to have a land acquisition referendum on the 2024 general election ballot, for voters to decide to use (or not) a property tax to fund natural lands and trails.

This video clip was written and directed by Lake County Commissioner Sean Parks with the help of a local videographer, two senior students from UCF studying Environmental Science and Political Science. His wife is the narrator's voice. No one was paid to do this video.

Those that value conservation land and our fragile ecological system understand there is so much more to the process than monetary value. Something we have found ourselves up against is combating the high monetary value developers are placing on our precious wildlife corridors, high recharge areas, wetlands, trees, agricultural and generally rural lands and how quickly they are obtaining these properties and converting them to urban living. The best we have been able to hope for is advocating lower density and bigger buffers.

In this introductory video, an attempt was made to begin to put conservation in monetary terms. Our "Green Infrastructure" is so much more than just low impact development techniques. It's more holistic and hopefully showing the monetary side will attract more support for a referendum and generally better educate those supporting clearcutting and bulldozing their way through Lake County. The concept of "Ecosystem Services" is used to show the economic importance and link to Green Infrastructure. In this introduction video TDR (Transfer of land Development Rights) is mentioned. There is a hope to make more videos that will also focus on outright acquisition or less than fee acquisition

#### OVAS Field Trip, Peg Urban's House (Leesburg, FL), 18 Nov 2024

Nine OVAS members gathered at Peg and Hal Urban's home in Leesburg, FL. The main purpose was to tour Peg's native plant garden surrounding all 4 sides of her house – the entire lot! She and her granddaughter had marked surplus plants for the taking. At one time Peg had counted 60 native species planted in her yard and she believes there are more now. When we finished pilfering plants, potting them for the trip to our homes, we sat down to consume our brown bag lunches and catch up on what everyone had been doing. We ended by singing Happy Birthday to Peg Lindsay and eating a beautiful cake provided by Peg Urban. We did create an eBird checklist for the visit.

Species noted are: Double-crested Cormorant , Black Vulture , Turkey Vulture, Bald Eagle , American Kestrel , Blue Jay , American Crow , Carolina Chickadee , Tufted Titmouse , House Wren , Northern Mockingbird , Palm Warbler

#### OVAS Program Meeting – My Favorite Plants for Birds Chester Residence, Tavares, FL 15 Oct 2023

OVAS members (7) and guests (1) gathered on the shoreline of Lake Harris for today's meeting. Peg Lindsay had compiled a PowerPoint from photos submitted by members of their favorite plants for birds. The presentation had been circulated as a pdf beforehand so that participants could download the presentation onto their individual tablets or phone to follow along. Each member discussed their favorite plants and explained why they chose them. Often discussions ensued. Afterwards

we shared native plant seeds and Peg Urban taught us to distinguish between the Hamelia species and cultivars to be able to identify the native one.


